Biological Resource Characteristics of Fire Stations Enrolled in the AFFF Program and 10-Day Hold Sites

The participating fire stations and 10-day hold sites are located throughout Washington State and in a variety of biotic communities that are home to diverse plant and wildlife species. We used geospatial data to identify known resources in proximity to proposed project locations. Data sources included statewide data from Washington Department of Fish and Wildlife, Washington Department of Natural Resources, and Washington State Department of Ecology, and national datasets, including the National Hydrography Dataset and National Wetland Inventory. We determined site characteristics through review of aerials and photographs using Google Earth and Google Street Map. Study area characteristics were derived from geospatial data using a study area of one-quarter mile around each site. No field or onsite visits were made for this analysis.
