Summary

This technical appendix describes the environmental justice conditions in the study area. It also describes the regulatory context, outlines methods for assessing potential environmental justice impacts of the types of facilities considered, identifies people of color populations and low-income populations, and assesses the potential impacts of the facilities and actions that could avoid or reduce impacts.

Revised Code of Washington 43.21C.535¹ requires this Programmatic Environmental Impact Statement (PEIS) to consider environmental justice and overburdened communities. This PEIS considers whether potential environmental impacts disproportionately affect people of color populations and low-income populations. The report also identifies where overburdened community areas are located in the study area. An overburdened community is defined as a geographic area where highly impacted communities and vulnerable populations face multiple combined environmental harms and health impacts.

Environmental justice impacts described in this technical appendix are summarized as follows:

- Green hydrogen facility development could have disproportionate impacts on historic
 and cultural resources, Tribes, and Tribal communities. The impact assessment and
 determinations of significance or non-significance would be determined through
 engagement and consultation with potentially affected Tribes and the Washington
 Department of Archaeology and Historic Preservation at the project level.
- Impacts to biological resources such as plants and animals that provide important subsistence and medicinal resources to Tribal communities would be determined with engagement and in consultation with each potentially affected Tribe at the project level.
- People of color populations or low-income populations may live in proximity to industrial
 facilities and be at increased risk of vibration impacts from certain construction and
 decommissioning activities. If a facility is located near people of color populations or lowincome populations, this would potentially result in disproportionate impacts on these
 populations.
- There would be public services and utilities and environmental health and safety risks associated with fire and explosion if activities required a large emergency response in remote locations with limited response capabilities, or if a fire or explosion during operations spreads rapidly or impacts large areas. Facilities with a BESS would also have risks from hazardous air emissions if a fire were to occur. If a facility is located near people of color populations or low-income populations, this would potentially result in disproportionate impacts on these populations.
- Impacts associated with public services and utilities and environmental health and safety
 would potentially result in significant and unavoidable disproportionate impacts on
 people of color populations or low-income populations. Determining if mitigation options

1 Introduction

This technical appendix describes environmental justice considerations and overburdened community areas in the study area and assesses probable impacts associated with the types of green hydrogen facilities, and a No Action Alternative, which are described in Chapter 2 of the State Environmental Policy Act (SEPA) Programmatic Environmental Impact Statement (PEIS).

This section provides an overview of the communities evaluated in this report and lists relevant regulations that contributed to the evaluation of potential impacts.

1.1 Resource description

The analysis in this technical appendix covers environmental justice considerations for the affected environment, potential impacts, and potential mitigation measures. Specifically, this includes identification of resources and areas potentially affected by the facilities and whether the area may include people of color populations or low-income populations, or whether it is an overburdened community area.

Revised Code of Washington (RCW) 70A.02.010(8)² defines environmental justice as:

...the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income with respect to the development, implementation, and enforcement of environmental laws, rules, and policies. Environmental justice includes addressing disproportionate environmental and health impacts in all laws, rules, and policies with environmental impacts by prioritizing vulnerable populations and overburdened community areas, the equitable distribution of resources and benefits, and eliminating harm.

An "overburdened community" is defined in RCW 70A.02.010(11) as "a geographic area where vulnerable populations face combined, multiple environmental harms and health impacts, and includes, but is not limited to, highly impacted communities as defined in Chapter 19.405.020 RCW." RCW 19.405.020³ defines "highly impacted community" as "a community designated by the department of health based on cumulative impact analyses in RCW 19.405.140⁴ or a community located in census tracts that are fully or partially on 'Indian country' as defined in 18 U.S.C. Sec. 1151.0."

Green hydrogen facility development could result in impacts to communities that are already overburdened by environmental impacts and could further affect community health and well-being. Green hydrogen facility development could have disproportionate impacts on Tribes and Tribal communities. The Washington State Department of Ecology (Ecology) is offering consultation with potentially affected federally recognized Tribes as part of the PEIS process,

and potential impacts to Tribes are discussed in the *Tribal Rights, Interests, and Resources Technical Appendix* and are not included in this report.

1.2 Regulatory context

Table 1 provides a list of relevant federal and state laws and policies that informed the evaluation of potential environmental justice impacts. Additional laws, plans, and policies could apply depending on the local jurisdiction in which a facility is proposed.

2 Methodology

This section discusses the geographic area that will be evaluated for potential impacts from green hydrogen facilities, provides an overview of the process for evaluating potential impacts on people of color populations and low-income populations, and describes the process for determining the potential impacts and potential mitigation. This section also describes how overburdened community areas were identified within the study area.

2.1 Study area

The study area for environmental justice conditions includes the PEIS geographic scope of study for green hydrogen facilities (Figure 1), and all census tracts that overlap the geographic scope of study. A total of 692 census tracts overlap the study area. Census tracts are subdivisions of a county that generally have a population size between 1,200 and 8,000 people, with an average of about 4,000 people. The primary purpose of census tracts is to provide a stable set of geographic units for the presentation of statistical data (U.S. Census Bureau 2022a).

The study area for the evaluation of environmental justice conditions associated with the construction and operation of green hydrogen facilities would be determined by the presence (or absence) of people of color populations and low-income populations during project-specific reviews.

Figure 1, which shows the geographic scope of study, does not include federal lands, national parks, wilderness areas, wildlife refuges and sanctuaries, state parks, or Tribal reservation lands.

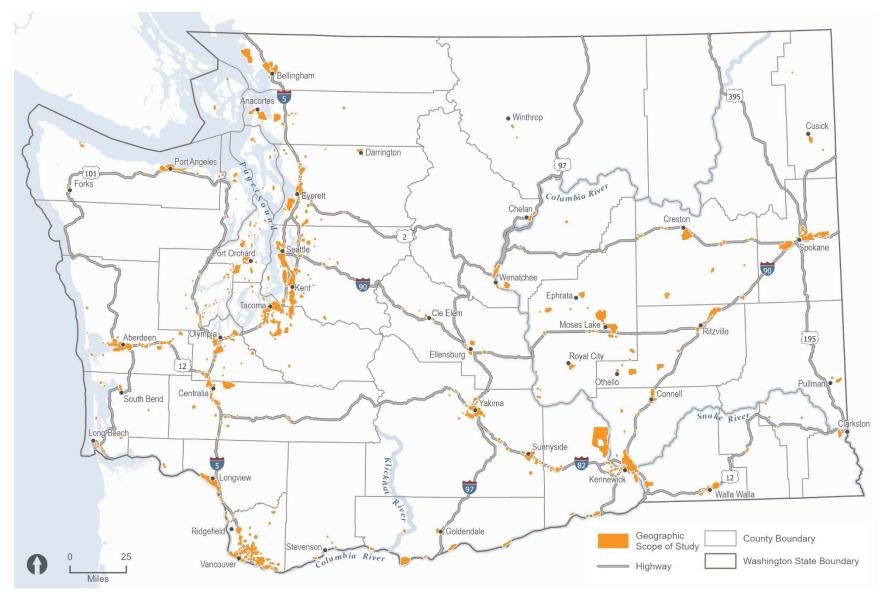


Figure 1. Green hydrogen PEIS geographic scope of study

2.2 Technical approach

Data were gathered and analyzed to determine if people of color populations, low-income populations, or overburdened community areas are present within the study area. The PEIS analyzes a timeframe of up to 25 years of potential facility construction and up to 50 years of potential facility operations (totaling up to 75 years into the future).

This analysis used 5-year population estimates from the U.S. Census Bureau's 2018–2022 American Community Survey (ACS) to determine people of color populations or low-income populations (U.S. Census Bureau 2022b, 2022c). Data from each census tract overlapping the study area were compared to the state of Washington as a whole, as follows:

- If the percentage of people of color in a census tract is greater than the state average (34% and above), that census tract was identified as "a people of color population." People of color were defined as all people who identify in the census as a race other than white alone and/or list their ethnicity as Hispanic or Latino.
- Census tracts with a percentage of low-income persons higher than the state average (23% and above) were identified as "low-income populations." Low-income persons were defined as those individuals with an income at or below twice the federal poverty level.

While this methodology captures only people who reside in the study area, it is acknowledged that additional people of color populations or low-income populations who travel to the study area for work or other reasons may also be affected by construction, operation, and decommissioning of facilities. This may include industrial workers and workers in service occupations in industrial areas.

Additionally, overburdened community areas were identified using data⁵ from the <u>Overburdened Communities of Washington State</u> dataset⁶ (OFM 2024). The dataset integrates data from the following three sources:

• Washington Environmental Health Disparities (EHD) Map (DOH 2024). The Washington Tracking Network (WTN) combines information on a variety of environmental and public health factors to produce a map that ranks census tracts in the state based on the cumulative environmental health impacts they face. The indicators that factor into cumulative environmental health impact scores fall into four categories: environmental exposures to emissions and other toxins; environmental effects, such as proximity to hazardous sites; sensitive populations; and socioeconomic factors. Census tracts are

- ranked on a scale of 1 through 10, with a higher ranking representing a higher level of burden compared to the rest of the state.
- The federal Climate and Economic Justice Screening Tool (CEJST) (which was available at the time the draft PEIS was released but has since been removed from the internet). CEJST represents data on indicators in eight categories: climate change, energy, health, housing, legacy pollution, transportation, water and wastewater, and workforce development. The tool uses this information to identify communities that the CEJST defines as disadvantaged, because they are overburdened and underserved.
- Tribal lands maps (as recognized by the Bureau of Indian Affairs).

A census tract was considered an overburdened community area if it met any of the following three criteria:

- Census tracts that have a ranking of 9 or 10 in the Environmental Health Disparities map
- Census tracts identified as disadvantaged by CEJST
- Census tracts that are wholly or partially overlapped by any Tribal lands

The specific methodology for identifying people of color populations, low-income populations, and overburdened community areas during project-level review should be coordinated with the lead agency for the facility's environmental review.

2.3 Impact assessment approach

The determinations of potential impacts and potential mitigation measures were reviewed for each element of the environment analyzed in the PEIS for each type of facility. Only resources that could affect people were considered for this appendix. Potential impacts that are less than significant are not anticipated to result in disproportionately adverse effects on people of color populations or low-income populations and are not discussed in this resource report.

Potentially significant adverse environmental impacts were overlaid with census tracts with people of color populations and low-income populations to determine the relative type and severity of effects and determine the potential for environmental impacts to disproportionately affect those populations.

This section uses analysis described in other PEIS technical appendices and considers potential impacts identified in those appendices that could affect people. Table 2 provides a summary of the impact determinations for each resource area.

3 Technical Analysis and Results

3.1 Overview

This section describes the population demographics within the study area and discusses probable impacts on populations from the facility types evaluated in the PEIS. This section also identifies overburdened community areas. These areas may require additional analysis for specific facilities during project-level review.

The analysis considered mitigation measures that could avoid, minimize, or reduce the identified impact below the level of significance. If facility impacts could be mitigated, they are not anticipated to result in disproportionate impacts on people of color populations and low-income populations.

3.2 Affected environment

3.2.1 People of color populations and low-income populations




Figure 3. Areas with people of color populations that overlap the study area – eastern Washington Source: ACS 2022

As described in Section 2.2, U.S. Census Bureau 2018–2022 ACS data were used to determine census tracts identifying people of color populations or low-income populations that overlap the study area (U.S. Census Bureau 2022b, 2022c). Data from each census tract overlapping the study area were compared to the state of Washington as a whole. If the percentage of people of color in a census tract greater than the state average (34% and above), that census tract was identified as a population of people of color. The census tracts that overlap the study area and that are a population of people of color are depicted in Figure 2 and Figure 3 and listed in Table 1-1 of Attachment 1. Of the 692 census tracts that overlap the study area, 275 census tracts (or 40%) are identified as having a people of color population.




Figure 5. Areas with low-income populations that overlap the study area – eastern Washington Source: ACS 2022

Similarly, census tracts with low-income populations higher than the state average (23% and above) were identified as low-income populations. The census tracts that overlap the study area and are identified as low-income populations are depicted in Figure 4 and Figure 5 and listed in Table 1-2 of Attachment 1. Of the 692 census tracts that overlap, 373 census tracts (or 54%) are identified as having low-income populations.

3.2.2 Overburdened community areas




Figure 7. Overburdened community areas that overlap the study area – eastern Washington Source: OFM 2024⁸

The census tracts overlapping the study area were evaluated for whether or not they meet the criteria described in Section 2.2 to be considered an overburdened community area. Of the 692 census tracts that overlap the study area,⁷ a total of 214 (or 31%) were identified as overburdened community areas. These census tracts are depicted in Figure 6 and Figure 7 and are listed in Table 1-3 of Attachment 1. The overburdened community areas identified are spread throughout industrial urban areas and rural areas across the state, with no particular pattern or clusters.

3.3 Potentially required permits and approvals

There are no specific permit requirements that pertain to environmental justice. Projects would need to comply with local plans, such as comprehensive plans and sustainability plans, which may include environmental justice elements.

3.4 Green hydrogen production facility

This section describes potential impacts of green hydrogen production facilities. For the purposes of the PEIS, the estimated footprint of a green hydrogen production facility, based on existing facilities in other areas, ranges from 1 acre to 10 acres, and the estimated height of structures is up to 100 feet, depending on the production method; type of storage facilities; and layout of external pipes and tanks, a parking area, and security fencing.

A green hydrogen production facility would typically include a connection to the electricity grid to power all, or a portion of, the facility's equipment needs and buildings. Facilities typically connect to the main transmission line through distribution lines that can be up to 100 feet high and between 1 and 8 miles in length, which would be determined by the project developer based on the distance between a selected site and existing electricity grid infrastructure. This technical appendix includes evaluation of impacts associated with distribution line connections to main transmission lines.

Off-site access roads may be needed to connect a facility to the existing state routes. Most of study area is less than 10 miles from a state route (63% within 1 mile and 99% within 10 miles). If needed, the project developer would determine the length of off-site access road needed, based on the distance between a selected site, existing road infrastructure and coordination with state and local departments of transportation.

3.4.1 Impacts from construction and decommissioning

3.4.1.1 Historic and cultural resources

Green hydrogen production facility development could have **disproportionate impacts** on historic and cultural resources. The impact analysis would be unique to each resource and would need to be conducted during future project-level review for facilities. The significance of Tribal cultural resources can be understood only from within the cultural context of an affected Tribe. Accordingly, the impact assessment and determinations of significance or non-significance would be determined through engagement and consultation with potentially affected Tribes and the Washington State Department of Archaeology and Historic Preservation (DAHP) at the project level. For more information on these resources, see the *Historic and Cultural Resources Technical Appendix*.

3.4.1.2 Tribal rights, interests, and resources

Green hydrogen production facility development could have **disproportionate impacts** on Tribes and Tribal communities. Tribal lands are part of the overburdened community area definition and are discussed in that context in this report. The significance of Tribal rights, interests, and resources can only be understood from within the cultural context of an affected Tribe. Accordingly, specific project impacts and determinations of significance or non-significance will be determined through project-specific engagement and consultation with each potentially affected Tribe at the project level. Potential impacts to Tribes are discussed in the *Tribal Rights, Interests, and Resources Technical Appendix*.

3.4.1.3 Biological resources

Construction and decommissioning could cause fragmentation of ecological communities that may affect the diversity of plant and animal species and migration patterns of animals; temporary vegetation removal and long-term recovery; changed ground conditions, such as soil compaction and minor drainage alterations, which may impact the ability of former biological communities to re-establish; and changes in water chemistry, temperature, or stream bottoms that affect aquatic species. Construction and decommissioning of facilities could result in the direct or indirect mortality of species and changes to habitats. Construction and decommissioning of facilities could result in impacts to larger animals such as deer, bobcats, coyotes, and foxes. Small mammals may also be affected, especially mice, shrews, and voles. Plants and animals provide important subsistence and medicinal resources to Tribal communities. Impacts on biological resources used by Tribal communities would be determined with engagement and in consultation with each potentially affected Tribe at the project level.

3.4.1.4 Public services and utilities

Depending on the specific location, fire severity, and emergency response capacity, construction and decommissioning would have potentially significant adverse impacts on emergency response. If activities required a large emergency response in remote locations with limited response capabilities or if there are other unique aspects of a facility site, impacts could exacerbate health disparities associated with the historical and current industrial land use conditions experienced by people in overburdened communities. If construction or decommissioning of a facility is located near people of color populations or low-income populations, this would potentially result in **disproportionate impacts** on these populations.

3.4.1.5 Noise and vibration

If vibration from specific construction or decommissioning activities occurs closer than 350 feet from residential land uses, or in close proximity to conventional or historic structures, a potentially significant adverse impact with respect to human annoyance or building damage could occur. If some types of blasting during construction are conducted within 2,000 feet of historic structures, it would result in a potentially significant adverse impact from vibration.

Due to the potential for people of color populations or low-income populations to be closer in physical proximity to industrial facilities, they may be at increased risk of adverse impacts. The

potential increase in vibration during construction and decommissioning would be temporary in nature but would potentially result in **disproportionate impacts** on these populations.

3.4.2 Impacts from operations

3.4.2.1 Historic and cultural resources

As noted in Section 3.4.1.1, green hydrogen facility development could have **disproportionate impacts** on historic and cultural resources. The impact assessment and determinations of significance or non-significance would be determined through engagement and consultation with potentially affected Tribes and DAHP at the project level.

3.4.2.2 Tribal rights, interests, and resources

As noted in Section 3.4.1.2, green hydrogen facility development could have **disproportionate impacts** on Tribes and Tribal communities. Specific project impacts and determinations of significance or non-significance would be determined through project-specific engagement and consultation with each potentially affected Tribe at the project level.

3.4.2.3 Biological resources

During operation, biological resources may be affected by continued fragmentation, vegetation maintenance and fire suppression, and increased traffic as well as increased potential to introduce invasive species. Plants and animals provide important subsistence and medicinal resources to Tribal communities. Impacts on biological resources used by Tribal communities would be determined with engagement and in consultation with each potentially affected Tribe at the project level.

3.4.2.4 Public services and utilities

Depending on the specific location, fire severity, and emergency response capacity, there is potential that operations would have potentially significant adverse impacts on emergency response if activities required a large emergency response in remote locations with limited response capabilities, a fire or explosion spreads rapidly or impacts large areas, or there are other unique aspects of a facility site. These impacts could exacerbate health disparities associated with the historical and current industrial land use conditions experienced by people in overburdened communities. If operation of a facility is located near people of color populations or low-income populations, this would potentially result in **disproportionate impacts** on these populations.

3.4.2.5 Environmental health and safety

The potential environmental health and safety impacts from operation would vary depending on the type of production technology used and quantities of materials present. Operating a green hydrogen production facility would involve the production, use, and storage of hazardous materials. Unintended hydrogen and methane releases during operations could cause fire and explosion. If a fire or explosion were to occur, it could result in property damage and injury or loss of life on-site. These impacts may also extend beyond the facility boundary. The severity of

these impacts would vary by the type of incident and land uses of the surrounding properties, as well as emergency response capabilities.

Hydrogen and methane explosion risk can be reduced, but may not be completely eliminated, through compliance with regulations requiring the proper siting, design, and operations. Depending on the specific location, severity, and emergency response capacity, operation activities would likely have less than significant to potentially significant adverse impacts from fires and explosions. Health disparities associated with the historical and current industrial land use conditions could be exacerbated if the operation-related risks of fire and explosion spread to surrounding areas near people of color populations or low-income populations. This would potentially result in **disproportionate impacts** on these populations. The severity of risks would need to be assessed for each facility based on the project location, production method, and quantities of flammable materials produced or stored on-site.

3.4.3 Measures to avoid, reduce, and mitigate impacts

The PEIS identifies a variety of measures to avoid, reduce, and mitigate impacts. These measures are grouped into five categories:

- **General measures:** The general measures apply to all projects using the PEIS.
- Recommended measures for siting and design: These measures are recommended for siting and design in the pre-application phase of a project.
- **Required measures:** These measures must be implemented, as applicable, to use the PEIS. These include permits and approvals, plans, and other required measures.
- Recommended measures for construction, operation, and decommissioning: These
 measures are recommended for the construction, operation, and decommissioning
 phases of a project.
- **Mitigation measures for potential significant impacts:** These measures are provided only in sections for which potential significant impacts have been identified.

3.4.3.1 General measures

• Laws, regulations, and permits: Obtain required approvals and permits and ensure that a project adheres to relevant federal, state, and local laws and regulations.

Rationale: Laws, regulations, and permits provide standards and requirements for the protection of resources and the PEIS impact analysis and significance findings assume that developers would comply with all relevant laws and regulations and obtain required approvals.

Coordination with agencies, Tribes, and communities: Coordinate with agencies, Tribes, and communities prior to submitting an application and throughout the life of the project to discuss project siting and design, construction, operations, and decommissioning impacts, and measures to avoid, reduce, and mitigate impacts. Developers should also seek feedback from agencies, Tribes, and communities when developing and implementing the resource protection plans and mitigation plans identified in the PEIS.

Rationale: Early coordination provides the opportunity to discuss potential project impacts and measures to avoid, reduce, and mitigate impacts. Continued coordination provides opportunities for adaptive management throughout the life of the project.

- Land use: Consider the following when siting and designing a project:
 - Existing land uses
 - Land ownership/land leases (e.g., grazing, farmland, forestry)
 - Local comprehensive plans and zoning
 - Designated flood zones, shorelines, natural resource lands, conservation lands, priority habitats, and other critical areas and lands prioritized for resource protection
 - Military testing, training, and operation areas
 - State-designated harbors
 - Air quality nonattainment areas

Rationale: Considering these factors early in the siting and design process avoids and minimizes the potential for land use conflicts. Project-specific analysis is needed to determine land use consistency.

- Choose a project site and a project layout to avoid and minimize disturbance: Select the project location and design the facility to avoid potential impacts to resources. Examples include:
 - Minimizing the need for extensive grading and excavation and reducing soil disturbance, potential erosion, compaction, and waterlogging by considering soil characteristics.
 - Minimizing facility footprint and land disturbances, including limiting clearing and alterations to natural topography and landforms and maintaining existing vegetation.
 - Minimizing the number of structures required and co-locate to share pads, fences, access roads, lighting, etc.

Rationale: Project sites and layouts may differ substantially in their potential for environmental impacts. Thoughtful selection of a project site and careful design of a facility layout can avoid and reduce environmental impacts.

- Use existing infrastructure and disturbed lands, and co-locate facilities: During siting and design, avoid and minimize impacts by:
 - Using existing infrastructure and disturbed lands, including roads, parking areas, staging areas, aggregate resources, and electrical and utility infrastructure.
 - Co-locating facilities within existing rights-of-way or easements.
 - Considering limitations of existing infrastructure, such as water and energy resources.

Rationale: Using existing infrastructure and disturbed lands, and co-locating facilities reduces impacts to resources that would otherwise result from new ground disturbance and placement of facilities in previously undisturbed areas.

- Conduct studies and surveys early: Conduct studies and surveys early in the process and at the appropriate time of year to gather data to inform siting and design. Examples include:
 - Geotechnical study
 - Habitat and vegetation study
 - Cultural resource survey
 - Wetland delineation

Rationale: Conducting studies and surveys early in the process and at the appropriate time of year provides data to inform siting and design choices that avoid and reduce impacts. This can reduce the overall timeline as well by providing information to agencies as part of a complete application for environmental reviews and permits.

- Restoration and decommissioning: Implement a Site Restoration Plan for interim
 reclamation following temporary construction and operations disturbance. Implement a
 Decommissioning Plan for site reclamation at the end of a project. Coordinate with state
 and local authorities, such as the Washington Department of Fish and Wildlife (WDFW),
 county extension services, weed boards, or land management agencies on soil and
 revegetation measures, including approved seed mixes. Such plans address:
 - Documentation of pre-construction conditions and as-built construction drawings
 - Measures to salvage topsoil and revegetate disturbed areas with native and pollinator-supporting plants
 - Management of hazardous and solid wastes
 - Timelines for restoration and decommissioning actions
 - Monitoring of restoration actions
 - Adaptive management measures

Rationale: Restoration and decommissioning actions return disturbed areas to preconstruction conditions, promote soil health and revegetation of native plants, remove project infrastructure from the landscape, and ensure that project components are disposed of or recycled in compliance with all applicable laws and regulations.

 Cumulative impact assessment: Assess cumulative impacts on resources based on reasonably foreseeable past, present, and future projects. Identify actions to avoid, reduce, and mitigate cumulative impacts. Consider local studies and plans, such as comprehensive plans.

Rationale: Cumulative impacts can result from incremental, but collectively significant, actions that occur over time. The purpose of the cumulative impacts analysis is to make sure that decision-makers consider the full range of consequences under anticipated future conditions.

3.4.3.2 Recommended measures for siting and design

The following siting and design considerations could be used to reduce impacts on people of color populations and low-income communities:

- Site and design projects to avoid adverse impacts to populations with environmental justice considerations and overburdened community areas.
- Use available information, including the latest Washington state guidance, and mapping tools to identify people of color populations, low-income populations, and overburdened community areas potentially affected by a proposed project.
- Engage potentially affected communities and local community service providers early in the process to understand concerns, identify potential impacts, and consider preferred mitigation options.

3.4.3.3 Required measures

This section lists required measures for use of the PEIS, as applicable, although there are no specific permit requirements that pertain to environmental justice:

- Ensure engagement and communications practices comply with Title VI and federal and state accessibility requirements and are culturally effective, linguistically appropriate, and accessible. Strategies include:
 - Engage with communities on how they prefer to receive information and tailor communications accordingly.
 - Use a variety of media tailored to affected communities, such as local print, online publications, and radio.
- Comply with local plans, such as comprehensive plans and sustainability plans, which may include environmental justice elements.

3.4.3.4 Recommended measures for construction, operation, and decommissioning

 Develop and implement public information sharing to provide technical project and environmental health information, including information on potential impacts and proposed mitigation, directly to potentially affected populations, overburdened communities, local agencies, and representative groups.

3.4.3.5 Mitigation measures for potential significant impacts

To address disproportionate effects on historic and cultural resources, Tribes and Tribal
communities, biological resources, public services and utilities, vibration, and
environmental health and safety, develop Community Benefit Agreements, Tribal Benefit
Agreements, community investments, or other agreements in coordination with
potentially affected communities and Tribes to address impacts through mutually agreed
upon mitigation. Examples of agreement outcomes could include measures to support
local labor, such as workforce development opportunities, or measures to support
community facilities and services.

Rationale: The process of developing agreements in coordination with local communities and Tribes allows people impacted by a project to participate in discussions that affect them. Such agreements can reduce the negative impacts of a project, especially to already overburdened communities, and promote broadly shared benefits.

3.5 Green hydrogen production facility with co-located battery energy storage system (BESS)

This section describes potential impacts of green hydrogen production facilities with up to two co-located BESS containers. The BESSs would be used to balance loads or to provide up to 15% of power in case of an outage or power quality deviation at a green hydrogen production facility. One BESS would provide 2.85 megawatts of electricity for 4 hours (a capacity of 11.4 megawatt hours or 11,400 kilowatt hours. Each container would be approximately 60 by 12 feet wide and 10 feet tall.

3.5.1 Impacts from construction, operation, and decommissioning

3.5.1.1 Historic and cultural resources

As noted in Section 3.4.1.1, green hydrogen facility development could have **disproportionate impacts** on historic and cultural resources. The impact assessment and determinations of significance or non-significance would be determined through engagement and consultation with potentially affected Tribes and DAHP at the project level.

3.5.1.2 Tribal rights, interests, and resources

As noted in Sections 3.4.1.2 and 3.4.2.2, green hydrogen facility development could have **disproportionate impacts** on Tribes and Tribal communities. Specific project impacts and determinations of significance or non-significance will be determined through project-specific engagement and consultation with each potentially affected Tribe at the project level.

3.5.1.3 Biological resources

Similar to construction, operation, and decommissioning of green hydrogen facilities (as noted in Section 3.4.2.3), construction, operation, and decommissioning of BESSs would have the same impacts on biological resources. Plants and animals provide important subsistence and medicinal resources to Tribal communities. Impacts on biological resources used by Tribal communities would be determined with engagement and in consultation with each potentially affected Tribe at the project level.

3.5.1.4 Public services and utilities

Because of the hazardous materials and additional fire risks of BESSs, specialized advanced planning and procedures for enhanced emergency response training would be required to ensure that the co-located BESSs do not generate hazards that could interfere with or exceed emergency response capabilities. A facility would result in potentially significant adverse impacts to emergency response for BESS fires if activities require a large emergency response in

remote locations with limited response capabilities, a fire or explosion spreads rapidly or impacts large areas, or there are unique aspects of a facility site. These impacts could exacerbate health disparities associated with the historical and current industrial land use conditions experienced by people in overburdened communities. If a facility is located near people of color populations or low-income populations, this would potentially result in **disproportionate impacts** on these populations.

3.5.1.5 Environmental health and safety

A BESS can create hazards for worker health and safety and firefighters and emergency responders, with the possibility of explosions, flammable gases, toxic fumes, water-reactive materials, electrical shock, corrosives, and chemical burns. A fire could result in the release of toxic air emissions. These air plumes can extend beyond the site and affect nearby workers or communities. Because of the hazardous materials and additional fire risks of BESSs, specialized advanced planning and procedures for enhanced emergency response training would be required to ensure that green hydrogen facilities with co-located BESSs do not generate hazards for the public or emergency responders and to reduce risks of BESS fire ignition and spread.

If a thermal runaway event due to damage or battery management system failure were to occur, facilities with lithium-ion BESS would likely have potentially significant adverse impacts due to hazardous air emission risks associated with the BESSs. Health disparities associated with the historical and current industrial land use conditions could be exacerbated if the operation-related risks of hazardous air emissions were to spread to areas near people of color populations or low-income populations. This would potentially result in **disproportionate impacts** on these populations.

3.5.2 Measures to avoid, reduce, and mitigate impacts

Measures to avoid, reduce, and mitigate impacts for green hydrogen facilities with a co-located BESS would be the same as those in Section 3.4.3.

3.6 Green hydrogen storage facility (gas or liquid form)

This section describes potential impacts of green hydrogen storage facilities. A green hydrogen storage facility could store hydrogen in gas or liquid form. Gaseous hydrogen would be stored in stationary, aboveground, cylindrical storage systems, each of which employs different construction materials to achieve maximum working pressure ratings. Liquid hydrogen would be stored in double-walled, vacuum-insulated cryogenic storage tanks. The footprint of storage facilities would depend on the amount of hydrogen to be stored but would be less than 1 acre. This includes the storage tanks, separation space between tanks (if more than one), on-site access roads, and ancillary equipment.

A green hydrogen storage facility may be co-located with a green hydrogen production facility, or it may be located at a standalone facility, transport terminal, or end-use location such as an industrial facility or fueling facility.

3.6.1 Impacts from construction, operation, and decommissioning

3.6.1.1 Historic and cultural resources

Green hydrogen storage facilities could interrupt the organic forms and colors of existing landforms and vegetation, which could adversely impact the visual integrity of areas of significance and historic and cultural resources that are sacred to Tribes. There is also the potential to adversely impact unrecorded archaeological sites. The severity of disturbance would depend on the locations of hydrogen storage facilities relative to historic and cultural sites. Similar to the description in Section 3.5.1.1, green hydrogen storage facilities would potentially result in **disproportionate impacts** on historic and cultural resources. The impact assessment and determinations of significance or non-significance would be developed through engagement and consultation with potentially affected Tribes and DAHP at the project level.

3.6.1.2 Tribal rights, interests, and resources

The introduction of green hydrogen storage facilities could lead to additional ground disturbance if co-located with a production facility or BESS, which could further interrupt access to Tribal resources during construction, operation, and decommissioning. Similar to the descriptions in Sections 3.4.1.2 and 3.4.2.2, green hydrogen storage facilities would potentially result in **disproportionate impacts** on Tribes and Tribal communities. Specific project impacts and determinations of significance or non-significance would be determined through project-specific engagement and consultation with each potentially affected Tribe at the project level.

3.6.1.3 Biological resources

Similar to construction, operation, and decommissioning of green hydrogen facilities, as noted in Sections 3.4.1.3 and 3.4.2.3, construction, operation and decommissioning impacts of storage facilities would largely apply to green hydrogen storage facilities. Plants and animals provide important subsistence and medicinal resources to Tribal communities. Impacts on biological resources used by Tribal communities would be determined with engagement and in consultation with each potentially affected Tribe at the project level.

3.6.1.4 Public services and utilities

Liquid and gaseous hydrogen in green hydrogen storage facilities also pose fire and explosion risks similar to those described in Sections 3.4 and 3.5. These impacts could exacerbate health disparities associated with the historical and current industrial land use conditions experienced by people in overburdened communities. If a facility is located near people of color populations or low-income populations, this would potentially result in **disproportionate impacts** on these populations.

3.6.1.5 Environmental health and safety

Impacts to workers, the general public, and the environment from EHS risks described in Section 3.5.1.5 would apply to green hydrogen storage facilities, however these facilities would not produce hydrogen and have risks associated with the processing methods. Both liquid and gaseous hydrogen storage pose similar fire and explosion risk to those described in Section

3.5.1.5. Depending on the specific location, severity, and emergency response capacity, operation activities would likely have less than significant to potentially significant adverse impacts from fires and explosions. This would potentially result in **disproportionate impacts** on people of color populations or low-income populations. The severity of risks would need to be assessed for each facility based on the project location and quantities of flammable materials produced or stored on site.

3.6.2 Measures to avoid, reduce, and mitigate impacts

Measures to avoid, reduce, and mitigate impacts for green hydrogen facilities with storage would be the same as those in Section 3.4.3.

3.7 No Action Alternative

Under the No Action Alternative, agencies would continue to conduct environmental review and permitting for green hydrogen facilities under existing laws on a project-by-project basis. Green hydrogen facilities could have **disproportionate impacts** on historic and cultural resources and Tribes and Tribal communities. Green hydrogen facilities could have significant adverse impacts related to public services and utilities, environmental health and safety, and noise and vibration. Project-specific mitigation measures may not be sufficient to avoid or reduce impacts to less than significant. The No Action Alternative would potentially result in **in disproportionate impacts** on people of color populations and low-income populations.

3.8 Unavoidable significant adverse impacts

Green hydrogen facility development could have **disproportionate impacts** on historic and cultural resources and Tribes and Tribal communities. The impact assessment and determinations of significance or non-significance would be determined through engagement and consultation with potentially affected Tribes and DAHP at the project level.

Impacts on terrestrial special-status habitats and species may be significant and unavoidable. Determining if mitigation options would reduce or eliminate impacts below significance would be dependent on the specific project and site. Mitigation to reduce impacts below significance for terrestrial special-status habitats or species may not be feasible. Plants and animals provide important subsistence and medicinal resources to Tribal communities. Impacts on biological resources used by Tribal communities would be determined with engagement and in consultation with each potentially affected Tribe at the project level.

A facility may result in potentially significant and unavoidable adverse impacts related to public services and utilities and environmental health and safety if activities require emergency response in remote locations with limited response capabilities, or if a fire or explosion during operations spreads rapidly or impacts large areas. If a facility is located near people of color populations or low-income populations, this would potentially result in **significant and unavoidable disproportionate impacts** on these populations. Determining if mitigation options

would reduce or eliminate impacts below significance would be dependent on the specific project and site.
